## Application for a licence to import a dog or cat for detention in quarantine

- This form for animals which land and clear HM Customs in England/Wales should be completed by the owner of the animal or an authorised representative. - The application should normally reach Defra/Scottish Government **at least 1 month in advance of the animal being landed into Great Britain, however we will be able to issue licences quickly for animals that fail checks under Pet Travel Scheme (PETS).**

## CONDITIONS ATTACHING TO AN IMPORT LICENCE (ID 1 and ID 8)

### Condition 1

For those pets which land at one of the **ports** specified in Condition 12, the carrying agent is required to board the vessel and take charge of the animal and deliver it to quarantine. For those pets which land at one of the **airports** specified in Condition 12, the airline is only permitted to hand over responsibility for the animal to the authorised carrying agent to deliver it to quarantine. For those pets being transported via the Eurotunnel Shuttle Service, the carrying agent is required to travel to France and collect the animal from the Calais Terminal at Coquelles and deliver it from there to quarantine. The animal must be taken by the shortest practicable route, at the owners' expense. In accordance with the conditions of the Rabies (Importation of Dogs, Cats and Other Mammals) Order 1974 (as amended) the animal will be required to remain there until authorised to be released by the Department (normally 6 calendar months from the date of landing) or longer in the event of:

- an outbreak of rabies occurring at the place of detention; or
- the animal sharing accommodation with another animal or other animals and any of those animals dying;

the animal may be detained for such further period as the Department may direct. (Sharing accommodation will only be allowed in prescribed circumstances, and provided both the owner of the animals and the Veterinary Superintendent of the quarantine premises give a written undertaking to the Department that certain conditions will be met. Sharing will only be allowed if permission has been given in writing by the Department).

During the movement the animal - except for dams and unweaned litters and animals authorised to share its quarantine premises - shall not be allowed to come into contact with any other animal. The Carrying Agent shall be responsible for the safe delivery of the animal at the said authorised place of detention. The animal must not be handed over during transit to the owner or any other person other than the representative of the Carrying Agent.

### Condition 2

The animal shall be landed on or within the 6 calendar months immediately following the date specified in the Licence and only if contained in a suitable nose-and-paw proof secure container or crate. If consigned by air the container or crate must be of the appropriate International Air Transport Association (IATA) standards and the animal must travel as manifested cargo, in the freight compartment of the aircraft.

The relevant IATA design principle is that the container be large enough to permit the animal to stand in a natural position, turn around and lie down.

In no circumstances will the animal be allowed to travel in the cabin compartment or as accompanied passenger baggage. Additionally, whether consigned by sea or air, it may be embarked or emplaned for a destination in Great Britain only if an import licence issued by the Department has been produced to the shipper, airline or rail company prior to shipment and a red label (Form ID 10) supplied by the Department has been completed and affixed to the container or crate or, in the case of dogs transported by sea, displayed in the vehicle containing the animal.

All containers used for the carriage of dogs and cats to or through the UK must be:

- sufficiently rigid to prevent damage or distortion occurring during normal handling which could allow the animal to escape or be injured;
- fitted with external lifting handles that provide adequate protection to handlers;
- completely nose and paw-proof. Where mesh is used it should be:
  - for cats - must be no thinner than 2mm (16 swg) with a mesh size no larger than 2.5 x 2.5 cm (1 x 1 in);
  - for dogs - must be no thinner than 2mm (16 swg) with a mesh size no larger than 2.5 (1 in) wide and up to 7.6 cm (3 in) high;
- padlocked or fastened with a secure lock or bolt when in use;
- fitted with a solid floor or tray.

### Condition 3

As soon as practicable after arrival at the place of detention the animal shall either be vaccinated by the Veterinary Superintendent in charge, with rabies vaccine as specified by the Department or permission for vaccination to be waived for animals meeting Pet Travel Scheme (PETS).

### Condition 4

At the request of the owner the animal may be licensed to move to another authorised quarantine premise.

### Condition 5

In the event of the animal sharing accommodation with another animal or other animals and those animals becoming rabid during the period of their detention and isolation in quarantine, the Department may require the animal to be slaughtered.

### Condition 6

Should the animal to which the Licence relates die or be lost while in Great Britain, the person in charge of the animal shall immediately report the death or loss by telephone or fax to the Secretary at the appropriate Department.

### Condition 7

If the animal dies in quarantine, the Department may take, or require to be taken, such action as is considered necessary to determine whether or not the animal was infected with rabies at the time of its death and may dispose of the remains of the animal, or require them to be disposed of, in such manner as the Department thinks fit.

### Condition 8

The artificial insemination of any animal detained under the Rabies (Importation of Dogs, Cats and Other Mammals) Order 1974 (as amended), whether from animals similarly detained or otherwise, is prohibited. Further, the artificial insemination of any animal not in quarantine from any animal detained under the above-mentioned Order is also prohibited.

### Condition 9

Should the animal give birth to young while it is subject to the conditions of the Licence, the offspring will be detained in quarantine for the same period as the dam unless the Department directs otherwise.

### Condition 10

The Licence must be produced by the person in charge of the animal on its landing for inspection by an Officer of H M Revenue and Customs, and at any time on demand for inspection by an Officer of the Department or by the Police or county authorities.

### Condition 11

If, after the issue of the licence it is, in the opinion of the Department impracticable or undesirable for the animal to undergo quarantine at the place of detention specified in Condition 1 of this licence, the Department may require the animal to be detained and isolated at approved premises other than those specified.

### Condition 12

**Animals may only be landed at the following places:**

#### Ports

- Dover Eastern Docks
- Harwich, Parkeston Quay
- Hull
- Portsmouth
- Coquelles (Eurotunnel Terminal)

#### Airports

- Belfast
- Edinburgh
- Gatwick
- Glasgow
- Heathrow
- Leeds
- Manchester
- Prestwick

### Condition 13

Dogs and Cats may transit Malaysia (Peninsula) and Australia provided they remain within the perimeter of an international airport.

During transit between the place of landing and the authorised quarantine premises specified in Condition 1 of this licence, the animal shall at all times be confined in a suitable container or crate approved by the Carrying Agent also specified in Condition 1. The animal shall only be moved by authorised means of transport under the control of the Carrying Agent.

### Condition 14

Cats from Australia must have not been resident on holdings where during the past 60 days cases of Hendra disease have been confirmed.

### Condition 15

Dogs and Cats from Malaysia (Peninsula) must:

- have had no contact with pigs during at least the past 60 days prior to export;
- have not been resident on holdings where during the past 60 days cases of Nipah disease have been confirmed; and
- have been subjected with a negative result to an IgC capture ELISA test carried out in a laboratory approved for testing for antibody against the Nipah disease viruses by the competent veterinary authorities on a sample of blood taken within 10 days of export.

### Condition 16

In Great Britain, it is illegal to possess certain types of dogs. Therefore, if you bring one of these dogs into Great Britain, you could be prosecuted and the dog seized and destroyed. If in doubt, don't travel with it. Dogs covered by this ban are of the type known as:

- Pit Bull Terrier
- Dogo Argentino
- Japanese Tosa
- Fila Brasileiro
